

**OHIO DEPARTMENT OF JOB AND FAMILY SERVICES
INTERAGENCY SUBGRANT/SUBRECIPIENT AGREEMENT AMENDMENT 1**

This is Amendment 1 to the Interagency Subgrant/Subrecipient Agreement between the State of Ohio, Department of Job and Family Services (hereinafter referred to as "ODJFS") and Ohio Department of Mental Health (hereinafter referred to as "ODMH"), signed by ODJFS on March 24, 2010.

1. ARTICLE V, Section A is hereby amended to read as follows:

- A. The total amount of the federal award, including any enhanced FFP authorized by section 5001 of the American Recovery and Reinvestment Act is Seven Hundred Forty-Nine Million, Seven Hundred Seven Thousand, Three Hundred Twenty Eight and 00/100 Dollars (\$749,707,328.00). ODJFS agrees to transfer up to Three Hundred Ninety-Five Million, Eight Hundred Twenty-Eight Thousand, Four Hundred Eighty-Four and 00/100 Dollars (\$395,828,484.00) to ODMH in SFY 2010. ODJFS agrees to transfer up to Three Hundred Fifty-Three Million, Eight Hundred Seventy-Eight Thousand, Eight Hundred Forty-Four and 00/100 Dollars (\$353,878,844.00) to ODMH in SFY 2011. Additionally, ODJFS shall transfer non-federal Disproportionate Share Hospital (DSH) payments referenced in ARTICLE II, Section E, Paragraph 2 to ODMH. The total transfer of DSH payments shall not exceed Three Million, Six Hundred Twenty-Four and 00/100 Dollars (\$3,000,624.00) for State Fiscal Year (SFY) 2010. The total transfer of DSH payments shall not exceed Three Million, Six Hundred Twenty-Four and 00/100 Dollars (\$3,000,624.00) for State Fiscal Year (SFY) 2011. It is expressly understood by ODJFS and ODMH that the terms of this Agreement do not allow total compensation in excess of Seven Hundred Fifty-Five Million, Seven Hundred Eight Thousand, Five Hundred Seventy-Six and 00/100 Dollars (\$755,708,576.00) for the period set forth in ARTICLE IV.

All obligations under this Agreement are subject to the requirements of ORC 126.07.

2. All other terms of the Agreement are hereby affirmed.






